### Conditions of Entry

#### Eligibility

3. Previous entrants may not re-enter within 12 months of last Quest participation

#### Judging & Event Attendance

5. Attend presentations during the Nutrien Classic at AELEC Tamworth.

7. Attendance is **compulsory on days to be determined by CLF- subject to Nutrien program and YAQ schedule**.
